

Order No:- 590-GAD of 2018 dated:- 11-04-2018 in terms of criteria in vogue; and terms and conditions laid down in the notifications issued for the purpose; and
- iii. Whereas, the 02 candidates as per the list annexed herewith as Annexure 'A' of this notification have been found eligible by the committee and points awarded to their sports achievements as mentioned against each; and
- iv. Whereas, the committee has also recommended to conduct Physical Verification Test/Viva of the eligible candidates at Srinagar/Jammu to ascertain the proficiency of the game/sports opted by the candidate; and

The decision of the committee shall be final in such matters.

The eligible candidates shall report to Divisional Sports Officer (K), J&K Sports Council, Bakshi Stadium, Srinagar alongwith proper identification proof on 22-8-2024 from 11:00 A.M to 03:00 P.M. for physical verification test/viva. In case the candidate(s) fail to appear for physical verification test/viva on the scheduled date, his/her sports category weightage shall not be recommended to the BOPEE. Telephonic intimation to the eligible candidates shall be communicated on their cell numbers mentioned in application forms by the concerned Divisional Sports Officer J&K Sports Council before scheduled date.
